





2. The name of Trust will remain as Kundoorkonam Educational and Charitable Trust, having its registered office at Madavoor , Mankonam which will be changed from time to time such other place as the Trustees may deem fit and proper at their discretion.
3. The Trust shall be governed by the Board of Trustees, who are at present parties 1 to 3 herein.
4. The party first named Mr. Abdul Salam will hold the post of Chairman and Managing Trustee, who will be carrying out the day to day affair of the Trust and party Nos. 2 & 3 will be the Trustees. The managing Trustee will also be the chairman for life or till he resigns and he has contributed a sum of Rs.1,00,000/- (Rupees One Lakh only) and has handed over the same to the Trust for reconstituting the Trust which shall form the corpus fund of the trust.
5. In case any Trustee is resigning, the remaining Trustees will be at liberty to appoint new Trustee within the number mentioned above or for such period or on such terms as to the retirement and reappointment as the Trustees that may consider proper. If any Trustee dies, retires, become unfit or incapable to act , the surviving Trustees can induct a new Trustee on his /her place on consent of majority Trustees.
6. A Trustee may resign his/her office by communicating in writing to the Chairman and Managing Trustee.

**7. Area of operation:-**

The area of of operation of the Trust will be at any place within the territory of india.

**8.The objective of the Trust shall be:-**

- (a)To contribute for the development of education, progress of Madavoor Central Schoolsand College of Arts Science and Technology apart from the object of starting new schools,other Technical Institutions , Medical/Engineering Colleges and other institutions.

- (b) To give, provide and or render help and assistance in the matter of education in the institution run by the Trust to the economically weaker section of the community.
- (c) To Promote, advance and encouraged and or/aid in helping , promoting, advancing and encouraging primary secondary and higher educations including technical and medical education.
- (d) To foster and encourage education and training in the related matters in the institutions run by the Trust.
- (e) To borrow or raise monies , Secure, secure loans, secure money for all or any of the objects of the Trust with or Without security in a manner the Trustees may think fit including by Mortgage of properties held by Trust.
- (f) To raise money from financial institutions such as banks, individuals, government agencies and any other agencies with the approval of the Trustees.
- (g) To carry on all such acts, deeds or other things either alone or in conjunctions with other organizations or associations as are incidental or conducive to the attainment of the above objectivies of the Trust.

**9. Powers, duties and obligations of the Trustees.**

- (a) The Trustees shall have the power in general to acquire all things and so all acts necessary to carry out the objects of the Trust.
- (b) It shall be competent for the Trustees from time to time to frame, make and enforce all rules, regulations and by-laws not inconsistent with the express provisions of the Trust as the Trustees may deem proper for securing and facilitating the administration and management in detail of the various departments relating to the activities and affairs of the Trust and for calling and regulating the meeting of the Trustees and for appointment sub-committees which are generally necessary for the management of the Trust.

**10. Managing Trustee:-**

- (a) The Chairman and Managing Trustee also shall have the power to appoint Trustees, which appointment has to be approved by the next preceding Board meeting. The chairman and Managing Trustee has the power to appoint, remove or replace any Trustees.
- (b) Subject to the control and supervision of the Board of Trustees, the chairman and managing Trustee shall do the day today management and administration of the Trust. He may delegate his duties to another appropriate person of his choice in his temporary absence and the same has to be with the consent of majority of the Trustees. The Chairman and managing Trustee will be the manager of the school and other assets, both movable and immovable owned by the trust.
- (c) The Chairman and managing Trustee may appoint a person from the Board as Vice Chairman, as Treasurer, as Secretary etc, which designations have to be approved by the Board in the preceding meeting.
- (d) The Chairman and Managing Trustee will be the competent authority to execute and sign all documents, records etc.... for and on behalf of Trust / School The Chairman and Managing Trustee will appoint an auditor for the Trust with the approval of the Board of Trustees.

**11 Meetings:-**

- (a) The meetings of the Trustees Shall be held at least once in every three months and a minimum of four such meetings shall be held every year.
- (b) The meetings of the Trustees shall be convened and presided by the Managing Trustee.
- (c) The quorum for meeting shall be one third of the total number of Trustees for the time being or two Trustees whichever is higher.
- (d) The managing Trustee shall keep or cause to be kept a minute book of the proceedings of the meeting of the Trustees.

- (e) Within three months after the end of the financial year, the accounts of the Trust shall be presented before the meeting of the Trustees for its approval and then be audited by a Chartered Accountant appointed by the Managing Trustee.
- (f) It shall be lawful for the Trustees to pass any resolution if there is any matter to be decided urgently. Such resolution shall be confirmed in the next meeting of the Trustees.

**12. Bank Accounts:-**

Bank Accounts of the Trust including over draft accounts , Term loan accounts etc, shall be opened and operated Jointly by the Managing Trustee and Other Trustees.

**13. CONTRIBUTION:-**

The Trust is also empowered to accept contributions/donations and other financial aid from government or any other interested persons.

**14. Financial Year:-**

The accounting year shall be financial year ending 31<sup>st</sup> march every year. The Trustees are authorized to change the financial year ending on any other date.

**15. Amendments:-**

Subject to the prior approval, any clause of this Trust Deed may be amended by 2/3<sup>rd</sup> majority of the Trustees provided the agenda specially include the clause sought to be amended.

**16. Removal:-**

Majority of the Trustees will have the right to remove any of the Trustees and any of the Trustees can resign from the Trust at any time.

**17. DISSOLUTION:-**

The Trustees if so decided with 2/3 majority may dissolve the Trust and on dissolution, shall transfer the excess of assets which remain after satisfying all its debts and liabilities in the name of the Chairman and Managing TRUSTEE SINCE the Majority of assets held by Trust arise out from his own funds.
